This investigation is underway. The Government will not pre-empt the outcome of the investigation.

Key points

- The department takes all allegations of misconduct seriously which are reviewed against the basic requirements for approval under the Australian Education Act 2013 (the Act). This includes not-operating for profit, being financially viable, and fit and proper persons. Where non-compliance is identified the department takes action commensurate to the severity of the non-compliance.
- The reported allegations in relation to Cranbrook School are serious, and the department is reviewing the allegations to ensure the governing body of the Cranbrook School meets the fit and proper person requirements of the Act.
  - The Department has spoken to the NSW regulator, NSW Education Standards Authority about the matter.
  - The department has written to Cranbrook School regarding fit and proper requirements that are required to be met by approved authorities for schools under the Act. This follows allegations of toxic culture and bullying at Cranbrook School.
    - Previously, the department wrote to the school in 2022 and 2023 regarding overseas travel expenses.
- The Department is also writing to the Association of Independent Schools NSW seeking information relating to the services provided by AIS to its members (such as Cranbrook) and the investigations undertaken by AIS NSW relevant to this matter.
