The Department of Education (the Department) is responsible for considering applications to use the word 'university', or words or expressions with the same or a similar meaning (eg 'uni') in Australian company names, on behalf of the Minister for Education. Statement against criteria in the Guidelines

This statement should include any information that may assist in considering this application. It should refer to the **relevant criteria at sections 8 and 9** of the Guidelines, which include that approval will normally be given:

- a) to universities, entities controlled by universities, and Australian Government-funded Regional University Centres
- b) to other entities, if the proposed name itself accurately reflects the purpose of the company, and is not likely to mislead about that purpose, or to appear to operate as a university or imply a connection with a university.

If your business is **not** described at (a) above, your application needs to explain what the purpose of your business is and why the word 'university' or similar terms, like 'uni', is appropriate and does not mislead in any way.

- The purpose of such businesses cannot include providing education services, or information about education services.
- Note that the Department has a broad interpretation of 'education services', including teaching, training, workshops, tutoring, information sessions, advisory and support services.
- Applications for a business name that includes the term 'uni' should also explain the meaning of the term in the context of the proposed business name, to avoid any implied association with a university. For example UniWidget could be a business that intends to build and sell *Widgets* that could be used *universally*.
