Dear Michelle,

Thanks for your recent engagement in relation to clarifying matters pertaining to the scholarship eligibility for students relating to the 'Swinburne International Excellence Scholarship'.

The terms and conditions set out in the scholarship refer to a condition where a student "must maintain satisfactory academic performance, as defined by the university's Academic Progress Reviews".

According to Swinburne, the "academic review process is covered by the Academic Progress Policy and Academic Courses Regulations 2013". Regulations would be of higher order than a policy in the context of delegated decision-making power.

It is currently unclear how Swinburne has applied the definition of 'satisfactory academic performance' in the context of the scholarship program as defined under the Academic Courses Regulations 2013.


The Academic Policy states that "In accordance with the Academic Courses Regulations (Chapter 6), unsatisfactory progress may have consequences for students, such as conditions imposed on enrolment or exclusion from a course."

In reviewing the references Regulations, there are only two sections of the Regulations that define satisfactory academic performance – they are outlined under Divisions 2 and 3.

Advice received from the Scholarships team (as attached) indicates that no trigger to a revocation or alteration of the scholarship would occur in a circumstance where Division 2 of the Academic Courses Regulations 2013 applies. That is, in defining 'unsatisfactory academic performance' in a single study period, the University <u>will not change the</u> <u>scholarship eligibility</u>. It is of note that the Regulations also do not explicitly provide for a change in scholarship conditions as a power under the Regulations pertaining to consequences of unsatisfactory academic performance where Division 2 is applied.

However, Division 3 does provide such a power. This is outlined specifically under clause 65 of the Regulations under Division 3 as highlighted.

65. Consequences of unsatisfactory progress



This process, that is an exclusion of course, clearly sets out that a student who has not passed more than 50% of units is subject to clause 65(d).

It is therefore reasonable to conclude based on the advice of the Scholarships Team and the conditions set out under the scholarship, that only students who failed 50% or more units in two consecutive study periods may be

subject to an adverse decision in relation to scholarship awarded to that student and that this would occur at the point of exclusion and not where a student is deemed 'at risk'.

We contend that the only clauses set out in the Regulations pertaining to consequences of unsatisfactory academic performance relate to circumstances where a student must have failed more than 50% of units **across two study periods.**

We note that there are numerous incidences of students receiving notices for adverse changes to scholarships after just one study period, and, with no opportunity to be heard.

The condition set out itself in the terms and conditions of the scholarship states that the definition of 'satisfactory academic performance' make clear that it is in direct reference to the Academic Progress Review, which is then defined under the Academic Courses Regulations.

I am therefore not satisfied that there is any explicit provision that Swinburne can point to that enables the decision by the university to apply a change of scholarship when no such power exists in the Regulations.

Advice sought

I therefore seek urgent advice on how it is that the definition of unsatisfactory academic performance has been determined and the clauses/regulations relied upon to make such a determination in the context of the Academic Courses Regulations.



We recently reviewed your academic progress and unfortunately, you have not met the academic requirements of your Swinburne International Excellence Scholarship outlined in your offer letter.

According to your scholarship conditions, you must maintain satisfactory academic performance by passing 50% or more of your units, as defined by the <u>University's Academic Progress Reviews</u>.

What does this mean?

This means you are no longer eligible to receive your Swinburne International Excellence Scholarship at the full rate. Instead, your scholarship will be reduced to 30% from Semester 2 2022 and will then be subject to the following conditions:

1. You must maintain satisfactory academic performance as defined by the university's Academic Progress Reviews.

2. You must enrol in a minimum 75% of a full-time study load.

3. If your academic performance falls below an Average Mark of 70%, Swinburne reserves the right to revoke the scholarship.

Support available

We understand that university life can often be difficult and we're here to support you. You may wish to speak with your faculty's <u>Academic Development Adviser</u>, an <u>International Student Adviser</u> or a counsellor at <u>SwinCounselling</u>. We can also offer you <u>study and assessment advice</u>.

Can I ask for this decision to be reassessed?

If you believe you were unable to meet your scholarship conditions due to circumstances outside your control, you can submit an <u>online complaint</u> <u>form</u> outlining the details and any other information that may be relevant. You must submit this form within 21 working days from the date of this letter. If you need help with your submission, <u>Swinburne Student Life</u> can assist you.

If you choose to submit a complaint, you should continue to study and attend classes, and comply with administrative, financial and enrolment deadlines as usual. Unless the complaint outcome determines otherwise, your scholarship will be reduced to 30%.



Outcome: Further information required

The Swinburne International Excellence Scholarship is awarded to top students from around the globe in recognition of their outstanding achievements. As a recipient of one of the University's highest scholarships, you are expected to fully engage in campus life, act as an ambassador for the University and, importantly, to maintain strong academic performance for the duration of your studies (in addition to the standard academic progress rules).

The terms of your scholarship state that you must maintain satisfactory academic performance during your studies. This means a student is not maintaining satisfactory academic performance when they fail 50% or more of their units in any given semester or teaching period OR if the student has failed an enrolled unit (or its equivalent) for a second time.

Over the last two years, Swinburne has not actively verified whether scholarship holders have met the terms and conditions of their scholarships. With the return to on-campus study, we have begun to monitor these terms and conditions again and have sought to ensure that all students are advised of this.

As a result of not meeting the conditions of your scholarship, unfortunately your original scholarship has been revoked and replaced with a new scholarship valued at 30%. Please make sure to take note of the conditions of your new scholarship to ensure that you understand how to meet the conditions.

Submitting a request for review due to special circumstances

Swinburne understands that circumstances can change and impact your ability to study. If there were compassionate or compelling circumstances, i.e.circumstances outside your control that impacted your ability to study, please respond via return email advising the circumstances with <u>supporting documentation</u>within <u>tendays</u> of this email.

We can only review requests where special circumstances are evident, and you must provide documentary evidence to support your claim.

Examples include:

- study hampered by acute illness or condition
- · impacted unexpectedly by natural disaster
- family bereavement during the semester.

All medical claims must include a <u>medical impact statement</u>, to be completed by your professional practitioner and submitted with your response.

The following are NOT considered special circumstances:

- · Adjusting to study in Australia
- Working too many hours
- Inability to pay adjusted fees you may apply for a fee payment extension: please refer to the application form on the <u>website</u>
- Online study





Q1 Are you a current or former Swinburne student?





Q2 Are you or were you a recipient of Swinburne's International Excellence Scholarship?





Q4 Which of the following WAMs are included in your scholarship contract?









Q9 How likely are you to recommend the support to other students?





Q10 Are you still a Swinburne student?





Q12 Would you be interested in speaking to us (confidentially) about your experience?




