Q6. 1 - What do you see as the key priorities for a new Australian strategy for international education? [limit to 500 words]

One priority is promoting 'brand Australia' to the world, instead of multiple state brands.

There needs to be a formal international student survey, conducted by the Government, that International students understand they complete in order to improve the experience of future students. The data generated can be used by the sector, to hear from the student voice, and can be used to drive for improvements. The Government can also publish the 'improvements' made to the student experience, based on the feedback received.

We need to have a uniform grading scale across Australia. The National grading scale should be standardised and implemented in Universities and schools (possibly VET). This would replace the current system that is different among states and different Universities. We also need to have a National University Entrance examination - one that covers all states and territories of Australia.
