Q6. 1 - What do you see as the key priorities for a new Australian strategy for international education? [limit to 500 words]

*Gvt needs to appoint an International Education Advocate team who will be tasked with presenting and implementing international education opportunities and assist to overcome barriers and challenges to the sector's growth. *Gvt needs to strengthen visa offers in particular for HE students to keep up with the offerings of competitor nations

Q7. 2 - Students should be at the centre of the new Strategy. How can Australian education providers deliver the best possible student experience both now and in the future? [limit to 500 words]

*The Strategy needs to be further enhanced by new members from the private sector, whose perspectives and realities can be very different from mainstream universities and TAFEs. This must occur to be able to identify new opportunities and work jointly together to identify solutions to challenges, especially if these are different across various providers. Australian providers need to have a global mobility outlook for international education provision as mobility and exchange are key components in creating and maintaining international partnerships. Government, through this strategy, needs to ensure and enable a flow of people to help strengthen the connectivity and export opportunities for our international education sector.

Q8. 3 - What changes are needed to make Australia more globally competitive over the next decade? [limit to 500 words]

*Gvt must work closely with VET and HE sectors to share and identify good practice as to how providers can effectively support international students into employment and further study both in Australia and their country of origin. This will assist the sector to have evidence based international graduate outcomes which will enhance Australia's sector future plans and possible required changes. A good benchmark example is the UK's future skills-based immigration system which sets out plans for a new global immigration system which will support an open global economy in line with the country's industrial strategy. Such a strategy aims for a highly skilled, innovative and highly productive workforce and continues to place no limit on the number of international student that can go to study. There is a similar program available in Canada, which too is taking a large proportion of the Australian international education market. This is the competition that Australian international education is up against and which needs to be addressed, especially within this Australian Strategy for International Education. *The government must prioritise resources to support international education opportunities in Australia's key geographic regions, commencing with current maximisation of trade agreements which is key, as well as lobbying for more such trade agreements to come to being with major international education regions such as the Middle East, Africa and Latin America.

Q22. 3.1 - Policy and regulatory flexibility are important in enabling providers to innovate. How can we utilise these settings to pursue opportunities, and in what other ways can we work together to ensure Australia remains globally competitive? [limit to 500 words]

The government must work with providers to assist to resolve regulatory barriers through international agreements to ensure agreements include recognition of Australian qualifications inclusive of online and blended learning programs. Its important to provide regulatory advice to innovators in a transparent way, supporting experimentation and testing innovations. Streamlining regulatory approvals would also assist, especially by lessening the regulatory burden. The flexibility should incorporate collaboration allowances internationally on innovation. By assisting providers to be able to navigate different jurisdictions and interact with regulators is the way for Australia to remain globally competitive.

Our Australian qualifications need to provide all such skills in order for graduates to be job ready for any future work environments as the future of work is now being influenced and shaped by demographics, global economic power, rapid urbanisation, resource scarcity and technological breakthroughs, some or all of which we are yet to be skilled in to encounter.

5.1 - How can Australia improve employability outcomes for international students, ensuring students have the necessary the skills to compete in a globally competitive labour market? [limit to 500 words]

All students are required more and more to be "job ready" as the ultimate outcome of any graduation qualification. I recommend that the potential International Education Advocate team be the body to inform the international education sector of global opportunities linked to industry.
